

# **A View of the Competition Situation**

The competitive activities in the United States have been badly fractured over the past several years. The reasons and subsequent actions are a matter of history . . . as a matter of fact you can find multiple versions of the same events. We all have a tendency to bias the presentation, sometimes intentionally, sometimes not.

Recently we have had a group of people working hard to rectify the situation. While they have made meaningful progress, the gap seems too wide to bridge. Dick Rudlaff, Jim Birk, John Davis, Sam Parks and David Levin have been the key central players of late. There have been many secondary participants who have offered help as well. George Richard encouraged the group to get together and he hosted a meeting in Baton Rouge from which emerged a number of agreed-to items. In addition, it provided the springboard for subsequent development of a proposed structure to manage competition in the United States under the sanction of the Balloon Federation of America.

The proposed structure was aired before a number of competitive pilots through a variety of meetings and discussions. While these discussions could only include a small cross-section of competitive pilots, they none-the-less served as an opportunity for feedback and critique. The proposal was vague in the area of the business structure. It did however offer insight to the proposed board structure which met with resistance from many competitive pilots. The structure lacked representation from the pilot membership. The proposal was structured in this way to build a lean, responsive organization. The board constituents were recognized experts in developing competitive events.

The proposal was presented to the BFA Board of Directors at its Albuquerque Board Meeting in late September. It was discussed in executive session and in open session. Dick, Jim, David and Sam participated in the discussion. George Richard was also in attendance. Following discussions, a formal vote supporting the proposal in principle was held. The vote was six in favor, three against, one abstention. Following that vote it was thought that further development and clarification of the content would occur. Several days later an email to Sam Parks from Dick indicated negotiations would be discontinued and the agreements reached in Baton Rouge would be immediately rescinded. The reasons for this are not clearly delineated but hint at the difficulties the proposed Board structure faced, and the fact that the BFA Board did not unanimously support the proposal, even

though it was supported by the majority.

I respect the decision Dick has made. I am especially grateful for the efforts of the key players. I spoke with Dick and Jim after I learned of the decision and requested that we continue with the one agreement of sharing points through the balance of the calendar year. I requested this to minimize the disruption to the competitive pilots, fully recognizing that it will have little material impact because we are so late in the competition year. They agreed to consider the request.

The BFA has refocused attention on hosting another independent National Championships for 2006. Following very positive feedback regarding the '05 Nationals, we intend to conduct a similarly fun and competitive event as a training ground for the current US team headed for Japan, and to determine the team to represent the United States in the 2008 world championships in Austria. Whether aspiring to compete at the international level or not, this event promises to be another highly competitive and very rewarding event for all pilots and crews involved, once again in the pure spirit of competition.

# Forwarded from AOPA by Nancy Griffin, BFA Balloon Clubs Chairperson:

# Air Defense Identification Zone

Dear Type Club Member,

The Airworthiness Concern Distribution process has only been used for airworthiness related issues; however, we feel that the importance of the proposed rule on the Washington, DC Air Defense Identification Zone (ADIZ) and making it permanent needs to be communicated.

We believe the threat of the ADIZ becoming permanent is so serious that we have issued only our third national pilot alert in more than a decade to all of our members. We are asking everyone to file comments to this NPRM and are asking the type clubs to help in communicating this critical message. Please tell your members how important it is to submit comments in opposition to this rulemaking. This is not just an issue for those in the Baltimore/Washington, DC area; it is an issue that easily has the potential to impact anyone throughout the country.

Imagine this: Every time you want to fly - even to do touch and goes - you have to file a flight plan. Before you can take off, you have to get a transponder code, but the landline you call to get the code is busy most of the time. If there is an RCO (remote communications outlet) frequency for your airport, you can rarely get a timely response from an overworked controller. Services are falling off at your local FBO because business is down drastically. Soon, your favorite diner is gone along with other businesses that fail. Welcome to life within an ADIZ. But there's only one ADIZ, you say. It's around Washington, and that's hundreds of miles away. There's no chance it will ever affect me. Don't bet on it. New York City has had a "temporary" ADIZ. Chicago's Mayor Daley keeps pushing for one. At any of the other 29 Class B airspace areas across the country, there could be an ADIZ at a moment's notice. That's what happened in Washington, DC. The 'temporary' ADIZ was created on a weekend in response to a heightened national threat level, but after the threat level was reduced, the ADIZ remained. And now, the FAA wants to make it permanent and the same thing could happen anywhere.

To make filing your comments easier, we have developed a step-by-step guide www.aopa.org/adizalert/ to help your members' craft their message and submit them to the FAA and to copy their members of Congress. We ask that you include a link to this guide in your communications so that a coordinated message can be delivered in the comments.

The areas that we asked to be addressed include:

- Ask the FAA to hold public hearings on the ADIZ rule.
- The Washington, DC ADIZ is operationally unworkable and imposes major burdens on pilots and air traffic controllers alike, all with minimal security benefits, and it must NOT be made permanent.
- Protecting the unique assets in the nation's Capital is important, but this can be achieved with the existing requirements for the 15-mile Flight Restricted Zone (FRZ). This has been augmented by other security measures put in place around Washington, DC, including ground-based missile defense systems, more nimble air interdiction capability with U.S. Customs helicopters, and a laser warning system.
- The FAA must implement safer, more efficient and rational security procedures for the airspace in the Washington, DC area. Lighter aircraft, flying at slower speeds, should not be subject to the current ADIZ requirements for filing a flight plan, obtaining a unique transponder code and maintaining two-way communications with air traffic control.
- The proposed rule is flawed because the evaluation of the economic and operational impacts on pilots and aviation businesses and an analysis of alternatives are insufficient.
- No general aviation aircraft has ever been used in a terrorist attack. And the government has determined that not a single ADIZ violation was terrorist-related.

We appreciate your efforts in communicating the importance of this proposed rule.

# Reception to honor Weinmans - winner's of Shields/Trauger Award

The Balloon Federation of America (BFA) will be presenting the Shields/Trauger Award to Jim and Maxine Weinman of Indianola, Iowa at a special reception Saturday November 12 at 5:00-7:00p.m. at the National Balloon Museum, 1601 North Jefferson Way (Highway 65/69), Indianola Iowa. There will be a short awards presentation at 5:30. The reception is open to the public.

The Shields/Trauger Award is the highest award given by the BFA and it is given annually to recognize outstanding service to ballooning in the categories of notable flights, contribution to the science of aviation, important contributions to ballooning safety and exemplary service to BFA.

Jim and Maxine Weinman have worked on behalf of the BFA and were instrumental in the efforts to establish as well as operate the National Balloon Museum. Jim was an active member of the BFA from 1971 to 2003 and served in many leadership roles including president of Indianola Balloons Incorporate (IBI), Charter member and president of the museum Board of Directors, co-chair of the building committee, and he worked raising funds to build the current museum building. Jim and Maxine served as co-chairpersons for the combined BFA and IBI Balloon Museum committee which were responsible for ballooning exhibits each year at the U. S. National Hot Air Balloon Championships in Indianola. Maxine served as a member of the museum endowment committee as well as creating the museum's gift shop. Maxine initiated the museum gift shop by selling balloon pins and other items at the Nationals each year. Now the museum gift shop provides a significant portion of the funding for the operation of the museum. Maxine also became the curator of the museum's collections while it was housed in temporary locations and she remained curator after the new museum opened in 1988 and served in that capacity until 2003. Both Jim and Maxine were also involved in fund raising efforts for the 2003 addition to the museum.

Jim's involvement with BFA and the museum lasted for 28 years and Maxine's term of service lasted 25 years. They both retired from active involvement in 2003.

# Albuquerque 2005

Well, as the "newbie" I was told that I am required to write the article for the International Balloon Fiesta in Albuquerque. After several weeks of anticipation, Jim and Cheryl picked me up for the big trip about 6:30 p.m. on Thursday, September 29th. We quickly loaded up my stuff and were on our way to meet the Seymours, Denny Anderson, and Mark Weeks in Bevington. Brian, Chris, and Roger were running a little late, so we admired the legality of Denny's vehicle and trailer while we waited for them. Soon after, Brian radioed they were near the interstate and we were on our way. We had no real issues on the way down, outside of the high gas prices and some Maple Nut Goodies, apparently a mild trip compared to years past. About 14 hours after the start, they decided to "break the newbie in right" and have me drive the home stretch through the mountains and on into Albuquerque. We checked into the hotel and then went to the field for the pilots to register. Jim and Cheryl then went on a dentist scavenger hunt, and as the saying goes, third times the charm. I stayed with Seymours and we went to get a bite to eat at the "World's Worst BBQ."

Saturday morning, I woke up with high expectations of what was to be an incredible week. When we got to the field it turned out to be a little windy. Jim was in the second wave so he had plenty of time to decide whether or not to fly. As we watched the first wave take off, it was apparent that the winds, while flyable, were quite brisk and it didn't appear that they were going to let up. Jim chose not to fly which was fine by me as I got to take in the sights and just enjoy the spectacle my first morning in



Albuquerque. I quickly filled both memory cards on my camera. After the flight we did the usual tailgate where I was introduced to many people who, at the time, I thought I would never remember the names of, but I eventually did. Late Saturday afternoon we went back out for the inflation of the gas balloons. I had been warned that it was not the most exciting thing (I believe "watching paint dry" was the term used), but I

was interested in seeing it either way. We hung around for the night glow that was happening that evening and the actual launch of the gas balloons. After watching several

of the gas balloons begin their journey, we headed back to the hotel for some much needed rest.

Sunday morning we headed out to the field again, and I was as excited for the day's activities as I was the day before. Jim was in the first wave this morning and we launched early. Jim headed off toward the Rio Grande River and quickly flew off the map. One of the girls who worked at the dentist office showed up with her husband on Sunday and they knew the area well, which was a big help to us in the chase vehicle. Jim got back into the good graces of the crew after picking an easy access landing spot (AKA a road). We quickly packed up so we didn't block traffic. It was quite a sight from there though as we were able to look back through the valley and see the entire second wave launching from the field. It was a spectacular view. Sunday evening we were back out at the field and participated in the evening's glow.

Monday was another breezy morning to start with and all pilots were instructed to fly into the field. We went to the east of the field and watched for some time. Jim decided the winds were good enough and we got to work. Jim had told me I would be going along with him this morning, so I was obviously really excited for the flight. We took off and had the Albuquerque box working quite well in our launch field. We were up for some time before we ever left the field we launched in, but eventually we worked our way north of the field where we could drop down in between some other balloons and head south to the field. We had two things to do at the field this morning. First was the target. With a little assistance from Victoria's Secret, we flew right over one of the targets, good enough for fourth in Jim's division. We were happy, but the other pilot didn't seem quite as pleased with the way things turned out. Also we were to play Black Jack on the field; however we soon discovered the bags were not meant to be thrown long distances as neither baggie landed on a card. The landing on our flight became a talk of the week though. We were heading right for new balloon museum just to the south of the field and its huge glass windows in the front. While there were people there to catch us, we did end up landing about 60 yards in front of the windows. It would have been a nice picture of the balloon standing in front of the museum, but with the winds being brisk and other balloons looking at the same landing spot, we put it down and packed up as quickly as we could. It was a perfect flight and quite an experience, and as mandated by the rest of the group, a celebration was required for my first flight in Albuquerque (which I think was really the whole reason I was invited). Leaving out the unnecessary details, we'll just say that I learned how precious oxygen is and I will never think of Kahlúa the same way.

Tuesday was yet another breezy morning when we arrived out at the field. Pilots were allowed to take off from the field but there was no task for the morning due to the winds. The flight was strictly a fun flight at the pilot's discretion. Jim chose not to fly so I helped Scott Alsup, as they needed an extra person. Again, the balloons went over the Rio Grande River and Scott landed quite close to where Jim had just a couple days earlier. Wednesday morning was more of the same, windy. Jim was in the second wave so we sat and watched some of the first wave start their inflation. Many pilots were having a difficult time getting up and after about 150-200 balloons had launched, the field was closed and the task cancelled. Wednesday afternoon was the zoo party and we went for some food and drinks and to look at the animals. The highlight of the zoo (though I would guess that Gerald Knoll would have a different opinion) was the probably 20 phone calls he got from the "Albuquerque Police Department" informing him that Barb had been arrested and that he needed to send down money. Thursday morning we woke up to wind, lightning, and rain so it was a morning to sleep in. On Thursday evening we went out for the Special Shapes Glowdeo. Cheryl and I walked round and took pictures and collected as many balloon cards as we could. It was quite a sight.

Friday morning was an eerie morning at the field. As we looked up we could see the ceiling was low. At the pilot's meeting, we were told it was at approximately 2000'. However, as the morning went on, it appeared as though it was continuing to fall. Jim didn't feel comfortable flying in it as we had watched several of the ride balloons and shapes that took off from the field "disappear." All the other pilots were to fly into the field, and the pilots who stayed at the field (those that chose not to fly) had decided they would probably cancel the task anyway. We were proven wrong however, so we went up to the targets to watch those that decided to fly drop at the targets and attempt the pole grabs. It was quite a show as the pilots grabbed several poles. The box was working quite well this morning and we watched several balloons make 3 and 4 passes over the field, many choosing to land there after the targets were closed. Friday night was another Special Shapes Glowdeo and I volunteered to help Denny with the Champagne bottle. Though the wind was again strong, we

got the bottle up and with a little help from Oggy, it went back down.

Saturday morning I woke up realizing this was my last morning. Jim was in the first wave and with the winds being from the south, we were one of the very first balloons to launch (which we later discovered was a very good thing). The wind direction meant that flying into the Indian Reservation was a distinct possibility. Not very long after launch, Jim radioed that he was headed for the reservation and that we should head that way. Traffic was quite a mess as there is really only one way to get there and many of the balloons were headed that way. Jim radioed that he had landed in the reservation and a couple of the police officers there had already granted permission and gave him the directions of how to get to him. After a while, we got to the entrance and immediately were stopped by police officers. After telling them we had a balloon landed in there, they told us to go ahead. We packed up and headed out without incident and from the sounds of things, we got a little lucky. There were many other balloons in there as well and apparently their crews had to wait for sometime in order to go in and get them. After saying our good-byes at the field we headed back and packed up at the hotel. We headed out about 1:00 pm Cheryl for inviting me to go along. I had a wonderful time and lots of memories. Also thanks to the rest of the Iowa group for welcoming me on the trip and letting me be a part of the Albuquerque experience. I hope that I can make it back again next year.

# **Directions to BOI Balloonport:**

**From East** on I-80 go south on Highway 65 Bypass (exit 141). Continue south on Highway 65 to the Highway 5 east exit (exit 72) - about 11 miles. Go southeast into Carlisle - 1 ½ - 2 miles. Go through Carlisle - continue on highway 5 about 2 miles - turn north on 190<sup>th</sup> Ave (2<sup>nd</sup> left after Carlisle). Go north about 1 mile. The Balloonport is on the east side of the road (if the road curves west, you've gone too far).

**From north** on I-35 - at the north mixmaster, go east on I-80 (exit 87). Go east to the Highway 65 bypass (exit 141). Go south on Highway 65 to the Highway 5 east exit (exit 72) - about 11 miles. Go southeast into Carlisle - 1½ - 2 miles. Go through Carlisle - continue on highway 5 about 2 miles - turn north on 190<sup>th</sup> Ave (2<sup>nd</sup> left after Carlisle). Go north about 1 mile. The Balloonport is on the east side of the road (if the road curves west, you've gone too far).

**From west** on I-80 - at the west mixmaster, go south on I-35 (exit 123B) about 4 miles to the Highway 5 bypass (exit 68). Go east on Highway 5 - 13-14 miles



to the Carlisle exit (exit 72). Go southeast into Carlisle -  $1\frac{1}{2}$  - 2 miles. Go through Carlisle - continue on highway 5 about 2 miles - turn north on  $190^{th}$  Ave ( $2^{nd}$  left after Carlisle). Go north about 1 mile. The Balloonport is on the east side of the road (if the road curves west, you've gone too far).

**From south** on I-35 - take the Highway 5 bypass (exit 68). Go east on Highway 5 - 13-14 miles to the Carlisle exit (exit 72). Go southeast into Carlisle - 1 ½ - 2 miles. Go through Carlisle - continue on highway 5 about 2 miles - turn north on 190<sup>th</sup> Ave (2<sup>nd</sup> left after Carlisle). Go north about 1 mile. The Balloonport is on the east side of the road (if the road curves west, you've gone too far).

From Indianola to the Balloonport - go north on Highway 65-69. Turn east on Scotchridge Rd. Follow that to Carlisle. Go east (Rt) on Highway 5 through Carlisle - continue on highway 5 about 2 miles. Turn north on  $190^{th}$  Ave  $(2^{nd}$  left after

Carlisle). Go north about 1 mi. **Or** Go east on Highway 92. Turn north on SR23. Follow that to Highway 5 (7-8 miles). Continue north across highway 5 to 190<sup>th</sup> ave. Balloonport is 1 mile north of Highway 5.
